Rules:

- *You must be 18 years of age or older with valid photo ID
- *The allotted time is 5 minutes, a stop watch will be used, no more than 2 dozen hot dogs per contestant
- *By submitting an entry in the contest, entrant contests to "The Dog House" and Tilbury BIA and Tilbury & District Chamber of Commerce using winner's name, address, likeness and prize information in publication and media
- *These are rules of the contest that allow for a food item to be separated, dunked, mushed and mashed in an effort to consume the most hot dogs
- *Food Warriors will be given five hot dogs and buns to start. There will be two cups of water for dunking or drinking, mustard and ketchup on the table for the contestants. When the last of the five hot dogs is in process of consumption, five more will be placed before the contestant
- *Should a Food Warrior be observed hiding their hot dogs, dropping them under the table, or placing them on another Warrior's plate he/she will be deemed in performance of a "Picnic Profanity" and will be disqualified
- *Food Warrior's who suffer a reversal of fortune and/or urges contrary to swallowing will be disqualified
- *Food Warrior's must keep the hot dogs submerged for a period of two minutes after the contest
- *The "Chipmunking Rule" will be in effect, which means that all food must be swallowed 30 seconds after the 1 minute buzzer
- *Gurgitators who are found to be in violation of the "Chipmunking Rule" will be penalized ½ hot dog
